- Natural, step, adopted, foster or domestic partner's children up to age 26

#### Benefits are effective on your date of hire.

# Gender Affirmation Support

Your gender affirmation journey is a personal one. Cigna Healthcare is here to support, respect and help you at every step as you become your best self. The My Personal Champion<sup>®</sup> gender affirmation support program is part of that.

### **How It Works**

You'll be assigned a Personal Champion and given access to their direct phone line. So every time you call, you'll speak with the same person who knows you, your history and your health needs.

#### Your Personal Champion is here to:

- Partner with you and your providers to help identify your best options so you can make the most informed decisions for yourself
- Help you understand your benefits and what's covered by your plan
- Connect you to the right care teams and resources based on your needs
- Coordinate care for pre- and/or post-surgery
- Put you in contact with in-network and experienced LGBTQ+-friendly providers
- Arrange transportation to and from appointments related to your procedure
- Locate community support and resource groups
- Provide social and medical transitioning support and more

#### **Kaiser Resources**

If you're a Kaiser member, you have access to equitable, compassionate and high-quality care. Begin your gender affirmation journey by visiting your primary care physician, who may introduce you to specialists or other caregivers. Coverage of gender dysphoria treatments may include:

- Mental health visits
- Gender-affirming lower- and upper-body surgeries
- Pre- and postoperative exams
- Vocal therapy
- And more

#### **HMSA** Resources

If you are enrolled in an HMSA plan, you have access to HMSA's Sexual and Gender Minority Support Program. Key aspects of this program include:

- Member care management and coordination
- Management of preexisting conditions, preventive care and recommended treatment
- Referrals to trustworthy resources and services in the community

## Healthcare

We want you and your family members to feel valued, supported and celebrated for exactly who you are. That's why our medical plans cover a wide range of gender-affirming services. For a complete description of your medical coverage, please contact your medical carrier.

#### **Gender Affirming Services and Treatment Options**

Depending on the medical plan you enroll in, the following healthcare services and treatments **may be provided**:

- Gender-affirming reconstructive surgery
- Hormone replacement therapy
- Medical visits and lab services
- Puberty blockers
- Short-term medical leave

### In addition, your insurance plan may provide coverage for the following, if considered **medically necessary**:

- Facial feminization surgery
- Hair removal (electrolysis, laser treatment, etc.)
- Hair removal required for reconstructive surgery
- Lipoplasty (body fat removal or filling) for masculinization or feminization of the body
- Tracheal (windpipe) shave/reduction
- Travel and lodging expenses
- Voice modification surgery and/or therapy

Contact your medical carrier to receive more information on services and treatment under our medical plans.

#### **HIV Services and Treatment**

Our medical plans provide coverage for:

- Human Immunodeficiency Virus (HIV) testing Can include antibody tests, antigen/antibody tests and nucleic acid tests (NAT)
- **Pre-exposure prophylaxis (PrEP)**, including the injectable treatment; taken to prevent getting HIV
- **Post-exposure prophylaxis (PEP)** Must be taken within 72 hours of exposure to HIV and can prevent the virus from taking hold
- Antiretroviral therapy (ART) Involves using two or more antiretroviral drugs to suppress the virus to undetectable levels in the blood and slow the progression of the disease


#### **Resources at Your Fingertips**


#### **Claims Denial Appeal Process**

# Family Building

Family planning is different and unique for everyone. Our benefits are here to make the process of forming a family a little easier.

#### **Medical Benefits**

Our medical plans **may provide** coverage for the following services. As always, consult with a reproductive specialist to decide which options are right for you, and contact your medical carrier to receive more information on coverage available.

- Cryopreservation (Cigna and Kaiser) –
   The process of using freezing technology
   to preserve biological reproductive
   material at extremely low temperatures.
   Cryopreservation techniques are used to
   freeze eggs and embryos, for example.
- Fertility treatment (Cigna, Kaiser and HMSA) – Fertility services are treatments and procedures to help you become pregnant after an inability to conceive a pregnancy or carry a pregnancy to live birth, either as an individual or with your partner. The definition of infertility varies by medical carrier but may also be based on an individual's medical, sexual and reproductive history, age,

physical findings, diagnostic testing or any combination of those factors. Interventions may be started in less than one year based on your medical, sexual and reproductive history, age, physical findings and diagnostic testing.

Cigna members also have access to WINFertility, a program that offers comprehensive and inclusive family-building benefits. Through WIN, you can talk to Nurse Care Advocates, receive assistance selecting network providers based on your treatment needs and more. And, through your medical or prescription plan, you can receive a \$25,000 lifetime maximum benefit toward certain eligible expenses related to fertility treatment and related fertility medications.

- In-vitro fertilization (IVF) (Cigna and HMSA)
   A series of procedures that involves the fertilization of gametes outside the body.
- Adoption and Surrogacy Assistance This program provides a one-time maximum reimbursement of up to \$25,000 to eligible Sunrunners. You can use this reimbursement amount to cover eligible, out-of-pocket expenses that you have incurred related to

the adoption or surrogacy process. Eligible expenses include adoption fees, surrogate agency administrative fees, legal fees and more.

### Paid Parental Leave and Pregnancy Recuperation

Once your new family member arrives, you may be eligible for a parental leave benefit of up to eight weeks of paid time off to bond with your child. A one-year waiting period applies to this benefit.

In addition, birth parents on approved shortterm disability (STD) leave may be eligible for a pregnancy recuperation benefit. This benefit "tops off" the STD benefit so that employees who are birth parents can receive 100% of their income while on leave.

If you plan to go on a leave of absence due to the birth or adoption of a child, please contact Broadspire to initiate the leave request and provide necessary documentation.



Employees in states that are eligible for wage replacement must apply for the state benefit. It is your responsibility to contact the state or appropriate vendor to apply and provide the necessary documentation.

#### **Prepaid Legal Plan**

MetLaw (Hyatt Legal), a prepaid legal plan, allows unlimited access to a nationwide network of more than 18,000 attorneys who can be used for a wide range of services, including adoption, will and estate planning.

# Mental Health Support

To give you access to a range of care options for your mental health needs, Sunrun has invested in a series of confidential resources to ensure that you and your loved ones receive inclusive and respectful support.

### Support Through Your Health Plan

Our medical plans offer enhanced mental health and substance abuse support with the aim of lowering your out-of-pocket costs:

- **Cigna PPO**: Waiving copays for both in-office and virtual mental health and substance abuse visits
- **Cigna CDHPs**: Waiving coinsurance for both in-office and virtual mental health and substance abuse visits after you meet your deductible
- Kaiser Plans: Waiving copays for both in-office and virtual mental health and substance abuse visits

### Employee Assistance Program (EAP)

The GuidanceResources EAP offers a series of confidential services and resources:

- Up to three free and confidential counseling sessions per person, per year, per issue— Talk with a licensed professional in person, by phone or through video about bullying, gender identity, body dysmorphia and other issues causing mental and emotional distress.
- Adoption assistance Find referrals for adoption attorneys, agencies, infertility specialists and support groups.
- Free 30-minute legal consultation and 25% off subsequent legal fees – Discuss legal matters such as adopting a child, guardianships, name changes, prenuptial agreements and more.
- Online library of articles on LGBTQIA+ issues
